

ANNOUNCEMENT ON THE TERMINATION OF ANZ VIETNAM'S RETAIL BRANCHES AND TRANSACTION OFFICES FOR TRANSFER TO SHINHAN VIETNAM

In April 2017, ANZ Bank (Vietnam) Limited ("**ANZ Vietnam**") entered into an agreement to sell its Retail business to Shinhan Bank Vietnam Limited ("**Shinhan Vietnam**"). Following ANZ Vietnam's request, the State Bank of Vietnam has issued official letter No.9390/NHNN-TTGSNH, No.2353/CucI.5, and No.1642/CucII.4 permitting the closure of the following branch and transaction offices of ANZ Vietnam so they can be transferred to Shinhan Vietnam. Accordingly, ANZ Vietnam has decided to close the following branch and transaction offices effective from 18th December 2017:

- **Le Thai To Branch**, at 14 Le Thai To street, Hang Trong ward, Hoan Kiem district, Hanoi;
- **Trung Hoa Transaction Office**, at VIMECO building, Lot E9, Pham Hung street, Trung Hoa ward, Cau Giay district, Hanoi;
- **Cau Giay Transaction Office**; at No.102, lot C, D5, Tran Thai Tong street, Dich Vong Hau ward, Cau Giay district, Hanoi
- **District 3 Transaction Office**, at 65 Pham Ngoc Thach street, Ward 6, District 3, Ho Chi Minh City;
- **District 5 Transaction Office**, at Ground Floor, Tan Da court, No. 86, Tan Da street, Ward 11, District 5, Ho Chi Minh City ;
- **Saigon South Transaction Office**, at No. 47 Nguyen Van Linh street, Phu My Hung Complex, Tan Phong ward, District 7, Ho Chi Minh City;
- **Tan Binh District Transaction Office**, at Ground Floor, No. 113-115 Cong Hoa street, Ward 12, Tan Binh District, Ho Chi Minh City.

ANZ Vietnam takes full responsibility for the liquidation of assets and liabilities, rights and obligations of the above branch and transaction offices in accordance with local laws and regulations.
