PURPOSE OF PROCESSING

ANZ collects and processes information about customers and visitors to its web site to conduct its business, to inform and make available products and services that may be of interest to you and for the development of web statistics. The information you provide will be used to contact you when necessary, e.g. to notify you about functionality changes to the web site and to offer services that you may find helpful (provided you have not opted out to receive such services).

SENSITIVE DATA

ANZ does not seek to collect sensitive personal data (such as data revealing political opinions, religious beliefs, health or other matters) through this site. If ANZ does seek to collect such data, your prior (explicit) consent hereto will be asked. Please note that, by providing ANZ with unsolicited sensitive personal data you (explicitly) consent to our using those data as described above.

COOKIES

ANZ may collect and analyse information in connection with the use of this web site, such as domain name, the number of hits, the pages visited, previous/subsequent sites visited and length of the user session. This information may be collected by using cookies. A cookie is a small text file containing relevant information which our webpage-server can extract from your browser. Our webpage-server may only require cookies that relate to information that has been exchanged between you and ANZ through the internet. Cookies not containing any security sensitive information can be stored on your hard disk in such a manner that they are available during the next visit. The only cookie that is saved from the secured domain on the hard disk is the cookie that is used for retaining the bank account and pass number on the login page. You can allow the use of cookies or prevent this by changing the settings of your browser. If you prevent the use of cookies, the mentioned information shall no longer be stored by your browser and with every visit your information shall be required and shall have to be completed again. Furthermore, the use of Digital Banking is not possible without the use of cookies. Specific settings regarding cookies depend on the type of browser.
